## Vocational Rehabilitation Workers Report High On-the-Job Injuries and Illnesses

Shortly after I started working with NRA in January of 2009, I received a call from the National Institute for Occupational Safety and Health (NIOSH), under the U.S. Center for Disease Control (CDC). NIOSH was starting to focus on what they call the “Social Assistance Subsector” to look at the health and safety of workers in various fields, including vocational rehabilitation, social work, child day care and home health aides.

At first, I did not see the relevance to NRA’s mission, but I have since seen the light. I initially thought about things like violence in the workplace or counselors that have to travel to meet with consumers in rural areas. I felt that those incidences were rather rare in our field and that the safety and health of VR workers was not a major concern. But, I soon learned that the statistics show a very different picture.

NIOSH held a meeting here in Washington, D.C., in early September 2010 to more fully flesh out their goals and strategies for improving the health and safety of workers in these social assistance fields. At that meeting, they shared statistics collected by the Bureau of Labor Statistics (BLS), under the U.S. Department of Labor, on reported on-the-job illnesses and injuries. The statistics, covering 2006 through 2008, show that individuals employed in the health care and social assistance fields report the second highest incidences of on-the-job injuries and illness (the field of “Manufacturing” is the highest).

Of course, this broader category includes direct health care providers as well as VR counselors. I figured that hospital workers would certainly have higher incidences than VR workers, and that is correct. However, when you look closer at the data, you can see that VR workers report higher incidences of workplace illnesses and injuries than the other groups in the Social Assistance Subsector. For example:

### **Incidence Rate of nonfatal Occupational Injuries and Illnesses Reported per 100 full-time employees — 2006-2008 (average)**

Social Assistance Subsector (total)	3.8
Individual and family services	4.0

Community food, housing, and emergency and other relief services	2.8
Child day care services	2.4
Vocational rehabilitation services	6.9 (!!!)

So, workers in vocational rehabilitation report a significantly higher number of incidences of workplace injuries and illnesses than do social workers, home health care workers, and child day care providers! What is going on here?

As I explored this question more fully, I learned that the category of “vocational rehabilitation services” includes, for example, everyone who would be employed at a community rehabilitation program – from the janitors through the Executive Director. Of course, some of those workers would have a much more physically demanded job than others. I then delved deeper into the matter and sought out statistics on VR counselors versus other workers in the field of vocational rehabilitation.

One of my contacts at NIOSH helped me to categorize the data for “rehabilitation” counselors (the term used by the BLS) and put it in perspective. Jim Boiano, Assistant Program Coordinator, Healthcare and Social Assistance Sector, NIOSH, put together the tables below.

Here are Mr. Boiano’s comments on this information:

“BLS also reports illness and injury incidence rates by occupation. I have attached two tables which present incidence rates by selected events or exposures (Table 1) and by natures (Table 2) for rehabilitation counselors, janitors and cleaners, and ‘all occupations’ to illustrate differences in rates among these diverse occupations.

As you can see, incidence rates [reported by rehabilitation counselors] for sprains/strains/tears, slips and trips, assaults, and ‘all other events’ are higher than the average rate for all occupations, and the rates for slips and trips and assaults are higher for rehabilitation counselors than for janitors and cleaners.

However, in most cases, the rates for janitors and cleaners for other events and natures are much higher than for rehabilitation workers.” [emphasis added]

I plan to continue my collaboration with NIOSH on this issue. NIOSH is very interested and supportive of NRA and has sent us materials that we disseminated at our 2010 Annual Training Conference in New Orleans. The materials addressed “Stress in the Workplace.” I hope to have other materials available to all members in the future. I am also exploring the possibility of a webinar or a teleseminar to explore these issues further. NIOSH has also provided bags that we will use at the 2011 Government Affairs Summit in March 2011.

The health and safety of individuals working in the profession of rehabilitation is a huge concern of the NRA, and we will do what we can to work closely with our members to ensure their safety and health. Peggy is the Administrator of the Business Relations Program for Alabama Dept. of Rehabilitation Services. She has been active member of Partnerships with Business since 1976 and has held many leadership roles throughout her career.

Her lecture entitled "Networking with Business Customers: Then, Now & How!" focused on the progress of the National Employment Network and its anticipated implications for the hiring of persons with disabilities across the U.S. by national companies.
